Terms and Conditions:

Champion Forward, Inc. (the “**Company**,” “**we**,” “**our**,” or “**us**”) respects your privacy and is committed to protecting the personal information of our users, including youth athletes, their parents or guardians, and coaches.

This Privacy Policy explains how we collect, use, disclose and safeguard your information when you use our website, platform, and related online services (collectively, the “**Services**”).

By using our Services, you consent to the practices described in this Privacy Policy. If you do not agree, please do not use our website.

1. Information We Collect

We collect information to provide and improve our Services. The types of information we may collect include:

a. Personal Information

When you register for an account or participate in training programs, we may collect:

- Name
- Email address
- Phone number
- Payment and billing details (processed through secure third-party payment processors).
- Team or organization affiliation (if applicable).

b. Usage Data

We may collect non-personal information automatically through cookies and analytics tools, such as:

- Time zone and language preferences.

c. Video and Interaction Data

If you or your child participates in virtual coaching sessions, we may collect:

- Video recordings or live session participation data.
- Chat messages or comments submitted during sessions.

This information is used only to provide coaching feedback, monitor safety and improve the learning experience.

2. How We Use Your Information

We use collected data for purposes including:

- To provide, personalize and improve training and coaching services.
- To communicate with users (including session reminders and updates).
- To process payments and manage subscriptions.
- To ensure the safety of minors using the platform.
- To comply with applicable laws and enforce our Terms and Conditions.
- For analytics, performance tracking and service optimization.

We **do not sell** personal information to third parties.

3. Protection of Children's Privacy

We comply with the **Children's Online Privacy Protection Act (COPPA)**.

- Users under thirteen (13) years of age must have verifiable parental consent before creating an account or participating in any online activity.
- Parents or guardians can review, update or request deletion of their child's information by contacting us at info@championforward.org.
- We do not knowingly collect more data from minors than is necessary to provide our Services.

4. How We Share Information

We may share information in limited circumstances:

- With service providers who help us operate our website, payment systems or customer support.
- With coaches or team administrators for training coordination.
- When required by law (such as to comply with a court order or legal obligation).
- All third parties are required to keep information confidential and use it only for the agreed purpose.

5. Data Retention

We retain personal data only for as long as necessary to:

- Provide ongoing Services.
- Comply with legal obligations.
- Resolve disputes and enforce agreements.
